You can still access grant funding to help cover the Immigration Skills Charge (ISC) under the new Home Office rules.

### **Available Grants:**

- ◆ Large Employers: Receive £1,619.50 (3-year CoS)
- ◆ Small Employers: Receive £665.50 (3-year CoS)

Whether you're planning to recruit or have already received a CV from a displaced worker, you may still qualify.

### **Driving and Cycling Safety: Important Updates for International Recruits**

International recruits must obtain a UK driving licence within 12 months of arriving. While an International Driving Licence may last longer, it cannot be used after the first year in the UK.

For some countries, you may exchange your home country licence for a UK licence. Check if you are eligible [HERE](#). If not, you'll need to pass a UK driving test within the year.

## Misleading Adverts re. eVisas

We have been made aware of an issue relating to a company charging for support in applying for an EVISA.

The Advertising Standards Authority (ASA) has made a ruling against Maki Online Services Ltd trading as 'NINO apply'.

They tried to attract business helping people apply for an eVisa through advertising emails saying that an expired BRP meant that they'd lose their status, be fined, deported and lose access to healthcare.

NINO apply's usual business is charging a fee for helping people prepare an application for a National Insurance number which would also otherwise be **free**.

The ASA ruled that the advert was misleading about the consequences and for omitting the fact that an eVisa could be obtained for **free** through the **Government website**.

They were told not to use the ad again and must tell people they could get an eVisa for **free**.

Please be aware and make migrant workers aware, that they may want to look out for these misleading or alarming claims being peddled by other firms. You may also want to make staff staff aware that either a NINO or E-VISA can be acquired for **free** through the **.gov website** and to contact their **local Citizens Advice** if they need more guidance.

## New Team Members!


